

The work so performed was required to be under the direct supervision and approval of the reclamation engineer, and settlements for the work done were to be in the form of certificates which, when approved by the project engineer, should be receivable in reduction of water-right charges levied by the Secretary of the Interior under the reclamation act. Each person performing work or furnishing materials or supplies under such a contract is 1572 required to file a stipulation or agreement to the effect that no cash will be paid for such work or materials or supplies, but in lieu thereof settlements shall be made and accepted by the issuance of certificates setting forth the value thereof, which shall be receivable in reduction of charges on lands in this reclamation project, in accordance with regulations approved by the Secretary of the Interior.
