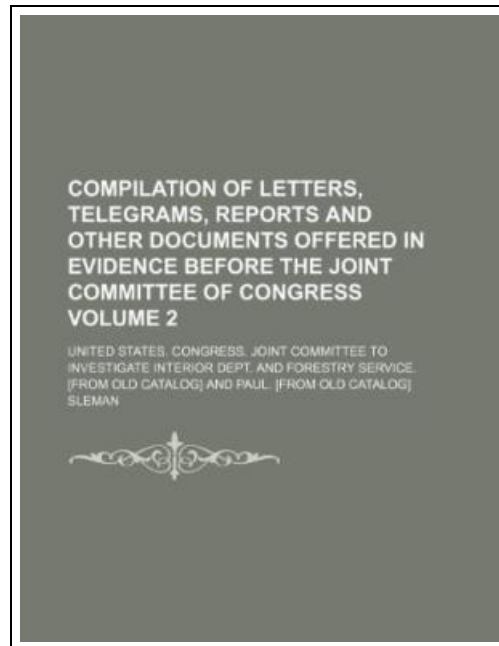

Not illustrated. 1910 Excerpt: . . . competitive bids to secure the work on the project or a portion of the project, to be done at the lowest passible rates, competition to be waived in specific cases. The work so performed was required to be under the direct supervision and approval of the reclamation engineer, and settlements for the work done were to be in the form of certificates which, when approved by the project engineer, should be receivable in reduction of water-right charges levied by the Secretary of the Interior under the reclamation act. Each person performing work or furnishing materials or supplies under such a contract is 1572 required to file a stipulation or agreement to the effect that no cash will be paid for such work or materials or supplies, but in lieu thereof settlements shall be made and accepted by the issuance of certificates setting forth the value thereof, which shall be receivable in reduction of charges on lands in this reclamation project, in accordance with regulations approved by the Secretary of the Interior. Upon certification by the engineer in charge as to the satisfactory completion of a definite section or portion of the work, or upon delivery or acceptance of supplies and materials, the association or settlers execute in duplicate certificates, which in substance are to the effect that work has been done or materials or supplies furnished to the value of upon the project, and that the amount will be credited on installments due or to become...
