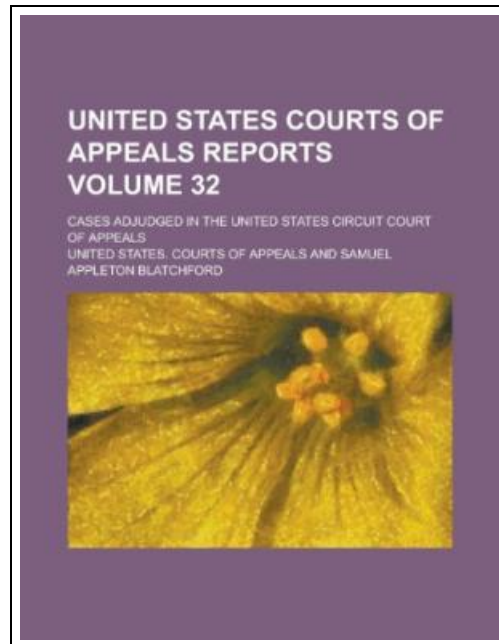

If the insured concealed any material fact which he should have made known to the company, or if any warranty was broken, the plea interposed fails to show what material fact was so suppressed or what warranty, if any, was broken. Cousleys application for insurance, which is set out in full in the pleadings, contains full and specific answers to all of the questions which the company saw fit to propound, and if any of the answers so made were false, the fact is not averred in the plea.
