

The state appropriation for funding the Courts is less than 1 of the state s total budget. The number of state paid judicial branch employees decreased by almost 9 this year, some as a result of the state s offered early retirement incentive, and other positions, including census authorized judgeships, have been left unfilled because of fiscal shortages. 
