

The first step in implementing this framework involves developing an econometric model explaining the components of the aggregate discrepancy, estimating the associated parameters, and generating the aggregate discrepancy s conditional expectation. The second step is to compare this model-based forecast with the discrepancy embodied in countries current-account forecasts. If the gap in discrepancies is below a critical value, then the discrepancy embodied in the countries current-account forecasts is not large. Otherwise, the discrepancy is large and calls for a careful reexamination of the associated current-account forecasts.
