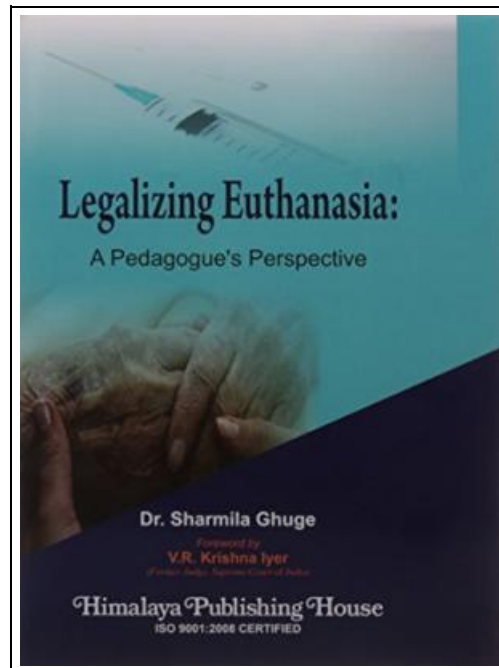

Euthanasia or right to die should not be for eternity considered to be intrinsically wrong, as required augmentation in legal arena shall not pose an insurmountable impediment to legalize euthanasia.
